Board elections were held at our AGM on May 23, 2014.

Discuss highlights/new developments:

- CCSBE has taken on the task of providing a review for Industry Canada on Measuring Entrepreneurial Performance in Canada.
- Our 2014 conference was held in Antigonish, NS, and was highly successful. Hosted by CEED and St. Francis Xavier, the theme of "Simplify the Journey" was popular with both academics and practitioners. The 150 attendees were educated, entertained and engaged with the excellent keynote speakers, sessions and workshops.
- CCSBE is happy to welcome three new Board members to the fold, Vickie Gray from Acadia Entrepreneurship Centre, Mario Pascucci, from the Centre for Business at George Brown, and Kadia Georges Aka from the Université du Québec a Trois-Rivières.
- Our Secretariat is working out well and is building an excellent database, usable template forms and process improvements.
- On a strategic level, we are zeroing in on the workable value proposition that will rebuild our membership in the coming year. We are re-defining our role in order to become a unique organization that will provide value to a variety of constituencies
- Initial discussions with USASBE point to the possibility of excellent opportunities for collaboration and mutual benefit.

Discuss key problems/challenges faced:

- The Board made a decision two years ago to disengage membership from conference attendance which has cost us dearly this year. We have gone from 126 members to 48 members by not requiring membership of conference goers. We will be re-establishing that connection this year.
- The move to locate CCSBE on the ICSB website has not been without its challenges. Lack
 of specific CCSBE branding on pages confused our members. Problems with on-line
 membership renewals exacerbated an already problematic downturn in our
 membership numbers. ICSB staff have been working with CCSBE to resolve some of the

many problems that resulted from this move and we believe that with the new planned website may resolve many of those issues.

Discuss any issues that require the Boards action:

- The logistical challenges of the new regional model for the Americas leads us to believe that this requires some adjustment to be workable and effective.
- We regret the lack of ICSB presence at our annual conference this year as well as the fact that there was no follow up to the keynote videotaping project that would have been very worthwhile.
