The 2014 Affiliate's membership meeting took place on 16 MAY 2014 at the Mayaguez Campus of the University of Puerto Rico. That same day the Affiliate held the 5<sup>th</sup> Faculty Lecture Series.

# F. MBA program in Haiti

The Affiliate President visited Haiti in May 2013 and met with officers of the University of Notre Dame in Haiti (UNDH) to initiate a dialogue so that the Pontifical Catholic University of Puerto Rico, the University of Puerto Rico and other Universities in the ICSB'S Puerto Rico and Caribbean Affiliate help UNDH establish the first MBA program in Haiti.

Furthermore, the Affiliate is collaborating with the Pontifical Catholic University of Puerto Rico in collecting textbooks that will assist UNDH establish a new library for its undergraduate program in Business. Over 6,000 textbooks have been collected and will be shipped to Gonaives in a few weeks, thus establishing the first phase of the new library in this Catholic University in Haiti.

- I. We are currently revising our recruitment strategy in Puerto Rico, islands, and nations that geographically encompass the Affiliate.
- II. We feel that the International Office does not take care and interest in developing and assisting the Affiliate as it does in other parts of the world.

Some Affiliate member's are currently involved in the establishment or operation of business incubators in Ponce, Puerto Rico with the assistance of the Ponce Municipal Government and the Ponce Workforce Investment Board (WIA).
